#### **Speaker Bios**



**Carolyn Raffensperger** is executive director of the Science and Environmental Health Network. She has an M.A. in Archaeology and a J.D. While working as an archaeologist in the desert Southwest of the U.S., she was enchanted by the beauty of the landscape and horrified at the environmental threats posed by dams, mining and toxic waste disposal. She left archaeology to work for the Sierra Club in Illinois. The desire to protect the rivers, prairie and desert led her to law school. Her graduate school training in archaeology and her law school education provide

the tools Carolyn needs to serve her clients—the future generations of all species. Carolyn co-convened the 1998 Wingspread Conference on the Precautionary Principle and the 2012, 2014 and 2016 Women's Congresses for Future Generations. Carolyn is co-editor of Precautionary Tools for Reshaping Environmental Policy published by M.I.T. Press (2006) and Protecting Public Health and the Environment: Implementing the Precautionary Principle, published by Island Press (1999).



**Dr. David Cwiertny** is the William D. Ashton Professor in the Department of Civil and Environmental Engineering (CEE) and a Professor in the Department of Chemistry at the University of Iowa (UI). His research broadly focuses on water quality and water treatment, with particular interests at the intersection of public health and policy. At UI, he directs the State-funded Center for Health Effects of Environmental Contamination (CHEEC), which conducts research to identify, measure, and prevent adverse health outcomes from exposure to environmental

contaminants. In 2016, he served as a Congressional Fellow for the American Association for the Advancement of Science (AAAS), working in the U.S. House of Representatives on the Committee for Energy and Commerce. David holds a BS in Environmental Engineering Science and a minor in Chemistry from U.C. Berkeley (2000), and a PhD in Environmental Engineering from Johns Hopkins University (2006).



**Gina Bell** is the Sustainability Director for the City of Dubuque. She is responsible for delivering the mayor's sustainability and resiliency priorities by working across city departments and with community partners to implement the Climate Action Plan. Gina graduated from Pacific University and served in the Peace Corps in Paraguay. Upon returning to the US, Gina worked at Adelante Mujeres focusing on trauma-reduction, regenerative agriculture, and marketing. She then focused on neighborhood economic development at Prosper Portland. Gina is passionate

about environmental justice. After 20+ years on the west coast, Gina returned to Iowa to address climate change in her hometown.
